
The Inland Empire Four Wheelers welcome all guests to participate in club functions such as runs, business meetings, Roundups, and social gatherings. However, we would also like to welcome in our guests as full time members. As an IE4W member, you will enjoy certain benefits, just to name a few; you will be allowed to purchase plaques to display on your vehicle, you will be allowed full voting rights for bylaw changes and board of directors elections and look toward some new fun members benefits in the coming months as our membership committee builds new ideas.

The followings are the requirements set forth by the IE4W bylaws for membership requirement: Each prospective member must be 18 years or older, hold a valid driver's license, be the registered owner of a 4x4 vehicle, have the minimum CA insurance coverage, have their vehicle safety inspected, and attend 6 business meeting and drive his or her vehicle in at least 6 official runs (1 being an overnight run and 1 Adopt-A-Trail work trip) within a 12 month period. An official club run consists of 2 or more club members (with the exception of monthly club Runs). Each new member must sign the club's Assumption of Risk Waiver and will pay an annual \$69.00 fee which is used for land use and club events. Each year new land disputes surface and every off-highway recreationalist is beckoned to help support the fight. So, not only will your IE4W membership be a fun, fellowship filled experience, you will also be supporting your right to enjoy off-highway recreational areas for years to come.

Safety Report

Well, It Looked Good!

I have been wanting to peek inside my JK "Teraflex FlexArms" where the pivot joint or Johnny Joint type system was hiding a dirty little secret. The problem that I have had in the past was that the grease fitting or zerk fitting didn't seem like it was taking the grease. Aside from that, I couldn't understand how the grease got to the center of the bushing when there wasn't a direct path for the grease to access it from the fitting. After knocking a couple of the fittings off on the rocks, I opted for a set screw, a ¼ x28 threaded hex with Teflon to protect the opening from contamination. Well, again, that didn't solve the problem, so this week, I pulled the lower arm from the rear axle, And, with a couple spare parts, made a compression device to compress the outer washer and remove the flex clip from the housing.

After driving out the Johnny Joint assembly from the housing, I opened the halves and discovered that the lubricant was not slippery like grease, but caked like hard grease because the zerk couldn't get the grease inside. After a closer look at the insides of the bushing halves, it appeared they were a polyurethane type material, but were impregnated in some places with small granular sand particles that made their way inside from the end openings. A rounded scraper fit the concave socket surface and dislodged all the particles. Once thoroughly cleaned, the halves were put together and reassembled into the housing. A pilot hole was drilled from the zerk fitting hole on the housing through the bushing to the center of the ball socket area.

Halves were removed and separated. A Dremel was used to open the grease path through the bushing half and de-bur the inside metal housing prior to re-assembly of the unit with some high pressure grease. A new zerk fitting was installed to replace the broken one. The parts used to compress the unit were re-applied to set the clip and it was returned to service. Only 7 more to go. The point of this safety article was to bring attention to the unseen parts that we need to have working dependably and properly. Regular inspection of moving parts for proper lubrication will allow the part to survive under stress. Parts crying for lubrication will eventually seize or gall the surfaces. Squeaks, creaking and other metal sounds might indicate surfaces are in contact without lubrication or have already failed. Listen and look at all your joints, universals, tie rod ends and check, service, or replace when necessary.

The run went well. I believe everyone had great time; I know I did. We aired down at the bridge over Deep Creek and hit the trail by 10:00 am.

Dishpan Springs:

Everyone went up the first obstacle near the start with little difficulty.

Robin with his long JK wheelbase turned into the "grand" canyon and easily climbed out up the left wall. Vargy also turned into the "grand" canyon and made it look easy climbing out the left wall. The rest of us have a short TJ or YJ wheelbase and did not try the canyon.

Holcomb Creek:

Most of us went thru Holcomb without incident, except for me. I was bypassing the easy line for the more/most difficult line. One spot has a smooth left side and a very large "V" notch on the right with crumbly decomposed granite sides and no exit at the far end. When I started to gently climb the left wall my Jeep sharply swung 90 degrees left leaving my Jeep with the spare tire hard against the right bank. I was able to move about 12 inches before 3 of my 4 wheels would spin; the left locker failed to engage. Robin had to pull me out of the "V" notch with a strap. No one else tried
